Executive Summary

The District Accountability System – Reporting, Evaluating, and Monitoring Instrument (DAS-REMI) is a data-driven accountability manual that provides measurable and transparent tool for assessing district performance in academic and non-academic areas. These objectives specify what the Superintendent and the administration will be focusing on to accomplish each of the Board’s strategic goals.

In accordance with Strategic goal 2.B.3, the Board of Education Police Department shall provide a report that tracks the number of fire, bus and school level crisis drills and exercises conducted at each school. This performance indicators track the completion of practice drills and the exposure to mocked or simulated crisis at the schools. These indicators are important as these activities expose the administration to crisis scenarios and engages them in high-impact learning practices to minimize risk.

A fire drill is composed of activities in which students practice leaving a place quickly so that they will know what to do if there is a fire. A school bus drill covers the location and operation of all emergency exits and the continued awareness to maintain access to all emergency exits in the bus. School level crisis exercise requires one (1) live and two (2) simulated crisis exercises

each school year to allow schools to become prepared during higher level school safety crisis involving active shooter or violence erupting scenarios.

For the first quarter (Q1) of the 2018-2019 school year (August - September 2018), the achievement rate for the combined Fire, Bus and School Crisis Exercises was 63.96%. There were 153 fire drills completed out of 160 required drills in district schools. There were zero (0) bus drills conducted this first quarter, accounting for the lower overall achievement rate. The bus drills are scheduled in to be conducted in the second quarter. In the report below, bus drills are designated as To Be Determined (TBD). The School District's Transportation division is responsible for scheduling the bus drills and the completed report will be available in the second quarter. For school level crisis drills, fifty-two (52) out of fifty-four (54) schools completed a required simulated (tabletop) exercise by the end of the first quarter.

New Changes in 2018-2019 DAS-REMI

In the 2018-2019 DAS-REMI guideline, **the key performance indicator (KPI) of Fire & Bus drills were combined with the School Level Crisis Exercises to become one KPI.** The present report is the first to combine these KPIs. Historical data were transposed to reflect the current reporting criteria.

The tables below show the fire and bus drills and school crisis exercises achievement summaries and followed by aggregation of completion status by Schools.

The above table shows a **63.96%** achievement rate for the KPI. Under the current reporting criteria, the actual completed drills and exercises were combined across three (3) subgroups- fire, bus and crisis exercises. **The lower rate is due to bus drills not being scheduled in Q1.**

Recommendations

- Bus drills should be scheduled when possible to occur within the first quarter of the school year to account for uniformity in all school safety drills.
- Charter Schools and Other school sites should be encouraged, if not required, to fulfil required school level crisis exercises. District schools are required to conduct one (1) live and two (2) simulated crisis exercises each school year. These exercises should be recommended for all schools under the funding umbrella of the school district. The exercises are important to create awareness and prepare schools for violent scenarios involving active shooters, and functional scenarios.
