

The resulting contract will be conditional upon formal approval by the Board and your firm's ability to comply with the requirements set forth in the Bid documents to include the following documentation.

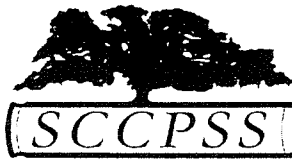
- Certificate of Insurance for the coverage and limits as specified in the sample contract document, with the District listed as additional insured and certificate holder.



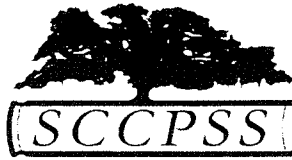


