**To Apply:** Call 211 at 912.651.7730 or dial 211 directly for eligibility screening, Monday through Thursday, 8:30am till 5pm and Friday 8:30am till 1pm.



## Requirements for All Funding

- Applicant's name must be on the lease
- ID for all adults in the household
- Current lease and dispossession warrant, eviction notice or past due notice

**Is someone in your household disabled (temporarily or permanently)? If so, you may qualify for assistance if you can provide:**

- Proof of disability

**Do you have household income? If so, you may qualify for assistance if you can provide:**

- Proof of income
- Proof of unexpected expense, lay off or loss of income within the past 90 days
- Demonstrate verifiable ability to maintain on your own once assistance is provided

**Has your household income been impacted by COVID19? If so, you may qualify for assistance if you can provide:**

- Proof of change in income due to COVID19
- Demonstrate verifiable ability to maintain on your own prior to this change in income

**Is someone in your household active duty military at Fort Stewart or Hunter Army Airfield? If so, you may qualify for assistance if you can provide:**

- Military ID
- Most recent end of month LES
- Proof of any other household income

**If you have lost your job or had hours reduced due to COVID19, need assistance with rent, mortgage or utility payments and reside in the City of Savannah, you may also qualify for CARES funds. Individuals must meet the following criteria to apply:**

- Must be able to provide proof of loss of income due to the COVID19 pandemic (from March 1, 2020 to August 30, 2020)
- Must be able to provide verification of current household income (receiving unemployment benefits, returned to work, new employment, SSI and SSDI, child support and alimony where applicable)
- Must be able to provide verification of past due rent/mortgage/utilities (copy of the most recent bill, copy of the mortgage statement, copy of the lease or statement from the property management company)
- Must provide identification of all members in the household



\*\*\*Funding offered on a first-come, first-served basis until allocation is gone. The City has until September 1, 2020 to use this grant. The allocated funds do not have to be paid back.

## Requirements

- ID for all adults in the household
- Proof of income
- Proof of monthly bills paid and owed
- Social Security cards or birth certificates for all household members
- If applicable – doctor's note of illness/time off of work, separation papers, job statement

## Requirements

- Served in active military, naval, or air service, and received a discharge status other than dishonorable
- Veteran's name must be on lease
- Gross annual household income less than 50% of area median income for household size
- At imminent risk of homelessness within 30 days
- ID for all adults in the household
- Proof of income for anyone 18 and older
- If zero income, need Wage and Earning Statement from Dept. of Labor for anyone 18 and older
- Current lease and dispossession warrant or eviction notice
- Social Security cards for all household members
- Proof of veteran status
- Three current months of bank statements from financial institution including pay cards
- If applicable – separation papers, job statement

- Demonstrate verifiable ability to maintain on your own once assistance is provided

## Requirements

- Verifiable documentation of household member living with HIV/AIDS
- Subsidized housing payments not available
- Must reside in Chatham, Effingham or Bryan County
- Current lease and past due notice, dispossessionary warrant or eviction notice
- Rent, Mortgage or Utilities assistance

## Requirements

- Applicant must meet income eligible requirements
- Applicant's name must be on the lease or mortgage
- Provide proof of change in income due to COVID 19, unexpected expense, lay off or loss of income within the past 90 days
- Provide current lease and dispossessionary warrant, eviction notice, or past due notice
- Must be a resident of Chatham County
- ID Card for all adults in the household
- Social Security Card for everyone in household
- Proof of income
- Proof of monthly bills paid and owed
- If applicable – doctor's note of illness/time off from work, separation papers, job statement
